Mayor Wilson commented on his term as mayor with remembering and rebuilding the City this past year in review: the Community Satisfaction Survey, celebration of the City's 90th Anniversary, Measure U, adoption of the first two-year budget, overdue accounting software update, public outreach on water conservation, award of drought relief grant, Long Range Property Management Plan, selection of new businesses in the City, affordable housing developments, Cherry Avenue Widening Project, Police Department accomplishments, and Mayor's personal recognitions.

Vice Mayor Forester moved to advance agenda item (c) for presentation.

c. 2014 General Plan Annual Progress Report

Community Development Director presented the staff report.

Mayor Wilson asked for any public and council comments.

Vice Mayor Forester thanked Mayor Wilson for directing the City Council this past year.

Council Member Woods announced that she requested the General Plan Annual Progress Report be presented as a City Manager Report item and thanked staff for the report.

b. City Council Reorganization

City Clerk declared nominations open for Mayor.

City Clerk asked for any Council discussion before the roll call vote.

Mayor Wilson expressed Vice Mayor Forester's value as a Council Member, his belief the title of Mayor should be an elected position rather than the existing annual rotation process and explained why he would not support Council Member Forester's nomination for Mayor.

Council Member Woods expressed Vice Mayor Forester's value as a Council Member and explained why she was not supporting his nomination for Mayor at this time.

Council Member Hansen commented on Vice Mayor Forester's re-election and expressed her support for his nomination as Mayor.

Council Member Noll voiced respect of City Council comments, expressed his concerns have been reassured and is in support of Vice Mayor Forester's nomination as Mayor. He asked the Code of Ethics be moved forward for Council approval.

Council Member Wilson called for roll call vote.
