The City of Signal Hill appreciates your attendance. Citizen interest provides the Council and Agency with valuable information regarding issues of the community. Meetings are held on the 2nd and 4th Tuesday of every month. In addition, meetings are streamed live on our website at www.cityofsignalhill.org, and are televised at 7:00 am, 2:00 pm, and 7:00 pm daily on Charter Spectrum Channel 3, and Frontier FiOS Channel 38.

Meetings begin at 6:00 pm with the conduct of any business permitted to be conducted in closed session by the Brown Act (Government Code Section 54950, et seq.), if any, and with the public portion of the meeting beginning at 7:00 pm. There is a period for public comment on closed session matters at 6:00 pm prior to the closed session. In the event there is no business to be conducted in closed session, the regular meeting shall begin at 7:00 pm. There is a public comment period at the beginning of the regular meeting, as well as the opportunity to comment on each agenda item as it arises. Any meeting may be adjourned to a time and place stated in the order of adjournment.

The agenda is posted 72 hours prior to each meeting on the City's website and outside of City Hall and available at each meeting. The agenda and related reports are also available for review online and at the City Clerk's office and the Signal Hill Community Center on the Friday afternoon prior to the Council meeting. Agenda and staff reports are also available at our website at www.cityofsignalhill.org.

During the meeting, the City Manager presents agenda items for Council consideration. The public is allowed to address the council on all agenda items. The Mayor may take agenda items out of order and will announce when the period for public comment is open on each agenda item. The public may speak to the council on items that are not listed on the agenda. This public comment period will be held at the beginning of the public portion of the meeting. You are encouraged (but not required) to complete a speaker card prior to the item being considered, and give the card to a City staff member. The cards are provided at the rear of the Council Chamber. Please direct your comments or questions to the Mayor.

a. Mayor Lori Woods will introduce the tenth week's presentation in a series focusing on the Red Cross program 21 Weeks to Prepare. The series is aimed at assisting individuals and families prepare for an emergency. Each City Council meeting will focus on items to add to your emergency supply kit and after 21 meetings your kit will be complete.

(12) CITY MANAGER REPORTS

a. Authorize Staff to Solicit Request for Proposals for Construction Management Services, for the Library Construction Project, No. 119

Summary: The City Council will consider authorizing staff to solicit a Request for Proposals for construction management services for the new Library construction, located at 1770 E. Hill Street.

Recommendation: Authorize the Public Works Director to solicit a Request for Proposals to select the most qualified and capable firm to manage the construction and related processes associated with the new Library construction.

b. Contract Services Agreement to Prepare an Updated Hazard Mitigation Plan

Summary: The Federal Disaster Management Act of 2000 (DMA 2000) requires every local, county and state government to have an approved Natural Hazards Mitigation Plan. In addition to minimizing the impact of future natural hazards on the community, completion of the plan also maintains the City's eligibility for future hazard mitigation funding following any significant disasters. Staff is seeking authorization to enter into a contract services agreement with Emergency Planning Consultants Inc. to complete an updated Hazard Mitigation Plan as required by CFR Title 44, Part 201.6: Local Mitigation Plans and the Disaster Management Act of 2000.

Recommendation: Authorize the City Manager to enter into a contract services agreement, subject to City Attorney approval as to form, with Emergency Planning Consultants Inc. for a total amount not to exceed \$25,000.

c. Contract Services Agreement to Provide Technical Services for an Automated Meter Reading (AMR) Equipment and Data Management Pilot Project

Summary: The City Council will consider entering into a contract with UtiliWorks Consulting, LLC, to assist in the planning and implementation of an Automatic Meter Read system.

Recommendation: Authorize the City Manager to enter into a Contract Services Agreement with UtiliWorks, in a form approved by the City Attorney, to provide technical consulting services related to the evaluation, design, procurement, and implementation of a water Automatic Meter Read system pilot project, in a not-to-exceed amount of \$33,780.

Recommendation: Approve Final Tract Map No. 72594.
