Meetings begin at 6:00 pm with the conduct of any business permitted to be conducted in closed session by the Brown Act (Government Code Section 54950, et seq.), if any, and with the public portion of the meeting beginning at 7:00 pm. There is a period for public comment on closed session matters at 6:00 pm prior to the closed session. In the event there is no business to be conducted in closed session, the regular meeting shall begin at 7:00 pm. There is a public comment period at the beginning of the regular meeting, as well as the opportunity to comment on each agenda item as it arises. Any meeting may be adjourned to a time and place stated in the order of adjournment.

(7) CITY MANAGER REPORTS

a. Planning Commission Interviews and Appointment

Summary: At its April 14, 2020 meeting, the City Council appointed sitting Planning Commissioner Perica Bell to serve for the remainder of a vacant term expiring May 31, 2023. This appointment created a new vacancy for a term expiring May 31, 2021. The City ran a second open recruitment seeking residents interested in serving on the Planning Commission for the remainder of the newly vacant term. Interested applicants from the first recruitment were included in the second recruitment. Tonight, the City Council will conduct interviews for those applicants previously not interviewed and will consider all qualifying candidates. At the conclusion of the interviews, City Council will make an appointment to fill one (1) unexpired Planning Commission vacancy for a term expiring May 31, 2021.

Recommendation: Conduct interviews and appoint one (1) individual to fill the unexpired Planning Commission vacancy. Term for the new Commissioner will run from May 12, 2020 to May 31, 2021.

b. Resolution Declaring Intention to Increase, Levy and Collect Assessments, Which Will be Adjusted Annually by the Consumer Price Index, for Landscape and Lighting Maintenance District No. 1 for Fiscal Year 2020-2021 and Approving the Engineer's Report.

Summary: Landscape and Lighting Maintenance District No. 1 was formed in 1992 to pay for the maintenance of common landscaped areas within the California Crown tract. Annually, the City Council must initiate proceedings to renew the levy and collection of special assessments for the Landscape and Lighting Maintenance District No. 1. The proposed resolution declares the Council's intention to increase, levy and collect assessments and approves the Engineer's Report, and sets the Public Hearing for July 14, 2020.

Recommendations: 1. Waive further reading and adopt a resolution declaring its intention to increase, levy and collect assessments, which will be

adjusted annually by the Consumer Price Index, for Landscape and Lighting Maintenance District No. 1 for Fiscal Year 2020-2021 and approving the Engineer's Report. 2. Set the Public Hearing for July 14, 2020. 3. Set an alternate Public Hearing for July 28, 2020, in the event a majority protest does exist on July 14, 2020, and direct staff to revise the Engineer's Report to indicate only the Consumer Price Index increase above the FY 2019-20 assessment with a decreased scope of services to target expenditures equal to assessment revenues.

c. Resolution Authorizing and Approving the Execution of a Cooperation Agreement with the Los Angeles Urban County Community Development Block Grant (CDBG) Program for Fiscal Years 2021-2024

Summary: The City Council will consider adopting a resolution authorizing the continued participation in the Community Development Block Grant (CDBG) program by entering into an agreement with the Los Angeles County Development Authority, formerly the Los Angeles Community Development Commission, to administer the program.

Recommendation: Waive further reading and adopt a resolution approving participation in the Los Angeles Urban County Community Development Block Grant program by authorizing the Mayor, or designee, to sign a Cooperation Agreement with the County of Los Angeles.

Summary: The developer for the Summerland Residential Development, ADC Signal Hill 16, LLC, is requesting approval of Final Tract Map No. 82304. Staff has determined that the final map substantially conforms to the approved tentative map and that the subdivision conditions needed for approval have been met. Staff is recommending approval of the final map.

Recommendation: Approve Final Tract Map No. 82304.

Summary: The Warrant Register is a listing of all general checks issued since the prior warrant register and warrants to be released upon City Council approval.

Recommendation: Authorize payment of Warrant Register dated May 12, 2020.
