b. Contract Services Agreement with Brightview Landscape, Inc. (Brightview) for the Maintenance of Landscaped Areas Citywide

City Manager provided an overview and Public Works Director introduced Contracts Manager who presented the staff report.

Council Member Woods and Council Member Wilson asked questions regarding Brightview and the contract services agreement.

Gerrad Hill, Associate Branch Manager with Brightview, City Manager, and Public Works Director addressed the questions posed by Council Member Woods and Council Member Wilson.

The annual amount may be adjusted by the applicable CPI in years 2 – 5, but will not be increased in any given year by more than 2%.
