A Regular Meeting of the Signal Hill City Council was held in-person and via video/teleconference on June 14, 2022 pursuant to the provisions of Government Code Section 54953 (as amended by AB 361).

Edward Wilson, Signal Hill resident, asked questions regarding the 2022 Engineer's Report and commented on the public comment procedure.

Public Works Director and City Manager addressed the questions posed by Mr. Wilson.

Alan Seigel, Signal Hill resident, spoke in favor of the proposed assessment.

Mayor Jones closed the public hearing at 7:56 p.m.

Mayor Jones recessed the meeting at 7:57 p.m. for the tabulation of assessment ballots.

City Clerk and Deputy City Clerk opened and tabulated the ballots.

Mayor Jones reconvened the meeting at 8:10 p.m.

City Clerk reported 90 assessment ballots were mailed to the property owners within Landscape and Lighting Maintenance District No. 1 and 43 of those assessment ballots were received prior to the close of the public hearing; 26 assessment ballots representing \$25,194.54 of assessments were submitted in support of the levy of the proposed assessments, and 17 assessment ballots representing \$16,021.63 of assessments were submitted in opposition to the levy of the proposed assessments.

City Clerk reported the assessment ballots in support of the levy of the proposed assessments outweigh the assessment ballots in opposition to the levy of the proposed assessments, therefore, there is no majority protest.
