(1) CALL TO ORDER – 7:00 P.M.

Chair Parker called the meeting to order at 7:06 p.m.

a. PUBLIC HEARING FOR SITE PLAN AND DESIGN REVIEW 19-02, A CONDOMINIUM SUBDIVISION (TENTATIVE PARCEL MAP NO. 082172) TO CONSTRUCT THREE DETACHED CONDOMIUM UNITS, AND ADOPTION OF A MITIGATED NEGATIVE DECLARATION ON PROPERTY LOCATED AT 2750 E. 20TH STREET WITHIN THE RESIDENTIAL HIGH DENSITY (RH) ZONE

Commissioner Richárd recused herself from the item due to geographic proximity.

Director Doan read the form of notice and Planning Manager Luis gave the staff report.

Chair Parker opened the public hearing.

Alin Chitanu, Signal Hill resident, stated he was in favor of the project but asked questions about the CEQA document and view impacts.

Bozena Jaworski, agent for the applicant, noted that the project was altered due to previous concerns about view impacts by reducing the number of units and reducing the height of the buildings.

There being no further public comments, Chair Parker closed the public hearing and called for deliberation from the Commission.

Commissioner Bell noted that revisions to the project had been made per previous comments.

Chair Parker encouraged staff and the applicant to address neighbor concerns about the construction process preemptively.

It was moved by COMMISSIONER WILSON and seconded by VICE CHAIR SAVOULIAN to Adopt Resolutions 866-10-18, 867-10-18, and 868-10-18, as amended.
