a. SWEARING IN OF THE NEWLY APPOINTED CIVIL SERVICE COMMISSIONERS

Summary:

At the April 25, 2023 City Council meeting, the City Council reappointed Ayda Ghebrezghi and Ronald Griggs to the Civil Service Commission each for a four-year term (May 31, 2027).
