Form of Notice: Notice was published in the Signal Tribune newspaper per Government Code §65091(a)(4) on June 9, 2023; was mailed to property owners within a 300' radius of the subject site on June 9, 2023; and was posted in accordance with Signal Hill Municipal Code Section 1.08.010 at City Hall, Signal Hill Library, Reservoir Park, and Discovery Well Park on June 9, 2023.

Kevin Scott, the authorized agent on behalf of the property owner, the Long Beach Firefighters Association Corp. Local 372 (LBFFA), is requesting a conditional use permit to operate a club as defined by Section 20.04.153 of the SHMC, to include holding events at their existing offices at 2201 Cherry Avenue as allowed in the Commercial Residential (CR) zoning district.
