Summary:

The City published a notice in the Signal Tribune newspaper per Government Code Section 65091(a)(4) on June 16 and 23, 2023; and posted the notice in accordance with Signal Hill Municipal Code Section 1.08.010 on June 16, 2023.

On May 25, 2023, the City Council reviewed the proposed updates to the City's Uniform Schedule of Service Fees and Charges as part of the Budget Workshop. Based on the information presented, the City Council directed staff to update existing fees and charges and proceed with a public hearing to consider adoption of the City's amended Uniform Schedule of Service Fees and Charges. - a. PROPOSED 2023-2025 COMMUNICATIONS PLAN

Summary:

The City of Signal Hill strives to provide clear, concise, proactive, transparent, and timely information to our residents, businesses, employees, and media outlets. Under direction from the City Manager, staff developed a Communications Plan that recognizes that our City has a diverse audience, promotes a transparent and honest atmosphere, and uses an omnichannel approach to communications by providing multiple mediums for residents and businesses to engage with the City Council and staff. The City Strategic Plan goals include the need to promote economic development and promote transparency in government.

The City's key objectives, as defined in this Communications Plan, include employing greater use of social media, developing marketing programs, and updating the City's website. With respect to both goals and objectives, the City has identified a specific need to proactively share information with the community and promote Signal Hill as a destination for business development.

The 2023-2025 Communications Plan prepared by staff would help the City organize these efforts and advance multiple communications objectives that serve the needs of the broader community.

Recommendation:

Summary:

The City Council will consider adopting the second year of a biennial budget for Fiscal Year (FY) 2023-24. The City Council reviewed the proposed FY 2023-24 (Year 2) Operating and Capital Budget (Operating Budget) at a budget workshop held on May 25, 2023. The Operating Budget, as presented, is structurally balanced per City policy. In addition, the City Council will consider a resolution adopting the annual appropriations limit for Year 2, known as the Gann limit.

Summary:

During tonight's meeting, the City Council will consider approving and adopting a City-Wide Pay Schedule and Management Salary resolution as required by the California Public Employees' Retirement System (CalPERS). The City Council will also consider approving and adopting new class specifications for three newly created full-time positions: Assistant to City Manager/Economic Development Manager, Communications Officer, and Emergency Management

Coordinator.

During the last 2020 labor negotiations, the City approved a 2% cost of living adjustment for Signal Hill Employees' Association members and 3% cost of living adjustment for Signal Hill Police Officers' Association Members, annually from 2021-2023. The effective date of both the Management Resolution and City-Wide Pay Schedule is July 1, 2023. The Management Resolution and City-Wide and Part-Time Pay Schedules must be approved and adopted by City Council in advance of the cost of living adjustment taking place.

With City Council approval of the proposed class specifications, staff would proceed with the necessary recruitment actions to get the new positions filled. The City's total Full-Time Equivalent (FTE) positions are thereby increased from 124.2 in FY 2022-23 to 128.75 in FY 2023-24. These additional 4.55 positions reflect the increase in full-time positions and part-time hours as proposed in the FY 2023-24 operating budget. Staff recommends these changes in order to enhance service to residents and businesses; the proposed changes are supported by ongoing revenues.

T.J. Janca Construction, Inc. (T.J. Janca) completed work for the Discovery Well Park Play Area Resurfacing Project (Portion of Project No. 80.23006), "Project", to the satisfaction of the Public Works Department and in accordance with the project plans and specifications. The final construction cost of for this project was \$82,357. Staff is recommending final acceptance of the work performed by T.J. Janca and release of retention withheld.

- c. MAINTENANCE SERVICES AGREEMENT WITH JJ PROPERTY MAINTENANCE NETWORK INC. FOR CUSTODIAL MAINTENANCE SERVICES

Summary:

The City Council will consider entering into a Maintenance Services Agreement with JJ Property Maintenance Network Inc. (JJP) for citywide custodial maintenance services for an amount of \$152,527.00 (plus 10% for contingencies) for a term of one year, with a maximum of two additional one-year term extensions. The services under this contract include janitorial services for city facilities including pressure washing of playgrounds at City parks, and on-call custodial services for special city events.

Recommendations:

1. Authorize the City Manager to enter into a Maintenance Services Agreement with JJP to provide custodial maintenance services of City building facilities, in a form approved by the City Attorney, with an annual contract amount of \$152,527.00. The term of the contract agreement is for a one-year term with a maximum of two additional one-year term extensions.
2. Authorize standard contingency of 10% (\$15,252.70) and up to a 180-day term extension pursuant to the City's Purchasing and Contract Guidelines, to be utilized if approved by the Public Works Director.

- d. RESOLUTION AUTHORIZING AND APPROVING THE EXECUTION OF A COOPERATIVE AGREEMENT WITH THE LOS ANGELES URBAN COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM FOR FISCAL YEARS 2024-2026

Summary:

The City Council will consider adopting a resolution authorizing the continued participation in the CDBG Program by entering into an agreement with the Los Angeles County Development Authority (LACDA) to administer the program for Fiscal Years (FY) 2024-26, effective July 1, 2024, to June 30, 2027. Adopting the resolution would allow the City to receive CDBG funds for future years.

Summary:

Los Angeles County (County) was granted funding from the State's five-year Permanent Local Housing Allocation (PLHA) grant program in 2020. Los Angeles County Development Authority (LACDA) was assigned to facilitate and oversee implementation of funded activities. In accordance with its Urban County Agreement with LACDA, the City of Signal Hill chose to participate in the PLHA program through an option to request local funds for alternate local activities related to implementation of the 6th Cycle Housing Element, as well as in the County's selected Eviction Defense Program. The City previously submitted for Year One and Year Two PLHA grant funds. Staff is recommending City Council approve the resolution for the Year Three PLHA grant funds.

Michael Baker International, Inc. (MBI) provides consultation services to staff to

support the City's Parks, Recreation and Library Services Department in the administration of the City's various Community Development Block Grant (CDBG) and Permanent Local Housing Allocation (PLHA) programs. The proposed amendment extends the term by one year through June 30, 2024 with a not-to-exceed contract amount of \$82,500.

Project Partners, Inc. provides professional consultant services for an Interim Water Superintendent to provide the Public Works Water Department with critical water utility services. The proposed amendment extends the term by 180 days through December 27, 2023.
