Form of Notice: Notice was published in the Signal Tribune newspaper per Government Code §65091(a)(4) on July 14, 2023; mailed to property owners and residents within a 300' radius of the subject site on July 14, 2023; mailed to property owners and residents on North Legion Drive and on the north side of East Hill Street between North Legion Drive and Rose Avenue on July 14, 2023; and posted in accordance with Signal Hill Municipal Code (SHMC) Section 1.08.010 at City Hall, Signal Hill Library, Reservoir Park, and Discovery Well Park on July 14, 2023.

Kevin Scott, the authorized agent on behalf of the property owner, the Long Beach Firefighters' Association Corporation Local 372 (LBFFA), is requesting a

Conditional Use Permit to operate a club as defined by SHMC Section 20.04.153, to include holding events at its existing offices at 2201 Cherry Avenue as allowed in the Commercial Residential (CR) zoning district.

Recommendations:

1. Adopt a resolution approving Conditional Use Permit 23-01, to allow operation of a club with associated, limited large events, entitled:

(13) CITY MANAGER REPORTS

- a. CONTRACT SERVICES AGREEMENT WITH JOHN KALISKI ARCHITECTS, INC. FOR CIVIC CENTER MASTER PLAN SERVICES

Summary:

The City Council will consider approving a Contract Services Agreement with John Kaliski Architects, Incorporated (JKA) for preparation of a Civic Center Master Plan, in the amount of \$218,915 with a contingency of \$31,085. The City released a Request for Proposals (RFP) for these services on May 5, 2023, with a proposal due date of June 15, 2023; the City received eight proposals by the deadline. Following staff review of proposals and interviews, JKA was the highest ranked firm. Based on the evaluation process, staff believes JKA is the best qualified firm to work with community stakeholders to prepare a comprehensive redesign of the Civic Center campus, develop conceptual site

plans based on feedback, and identify a funding plan for each option. If approved by City Council, JKA believes the work can be completed within a five-month period from the contract start date.

Recommendations:

1. Authorize the City Manager to enter into a Contract Services Agreement with John Kaliski Architects Incorporated for preparation of a Civic Center Master Plan, in the amount of \$218,915, in a form approved by the City Attorney; and
2. Authorize the City Manager to approve a contingency in the amount not to exceed \$31,085 to match the City Council's appropriation of \$250,000.

a. **CONTRACT AMENDMENT REGISTER DATED JULY 25, 2023**

Summary:

The Contract Amendment Register is a listing of proposed contract amendments and project change orders eligible for streamlined processing based upon the following criteria as documented in the City's Purchasing Policy:

- Funds have been authorized as part of the adopted fiscal year Operating Budget.
- Staff are satisfied with the goods/services received to date; and
- City Manager reviewed and approved each amendment for streamlined processing.

The contract amendments being presented for City Council consideration are as follows:

FCG Consultants, Incorporated: Services for Spring Street Bicycle Lane Gap Closure project (90.18003). Amendment No. 2 extends the term by nine months through September 30, 2023, and increases the compensation by \$41,019.56

due to project delays and additional services. The revised total not-to-exceed contract amount is \$322,712.56.

Tetra Tech, Incorporated: Services for Well 10 Construction project (95.18011). Amendment No. 2 extends the term by 5 months through November 30, 2023, and increases the total compensation by \$17,000 to a new not-to-exceed contract amount of \$475,000 for additional services for permit information.

Architerra Incorporated dba Architerra Design Group: Professional design services for Hillbrook Park Renovation Design project (80.23007). Amendment No. 1 extends the term by 8 months through March 30, 2024, due to scheduling delays and to provide additional support services.

SWA Group, Incorporated: Professional architectural design services for the Citywide Median Landscape project (90.23006). Amendment No. 1 extends the term by 10 months through May 30, 2024, due to scheduling delays and provide additional support services; the amendment does not provide additional compensation.

Recommendation:

Authorize the Contract Amendment Register dated July 25, 2023.

b. RESOLUTION AMENDING THE CONFLICT OF INTEREST CODE

Summary:

Government Code Section 87300 et. seq. requires local governments review their respective conflict of interest code to determine its accuracy or make amendments as necessary. Currently, staff believes it is necessary to amend the City's Conflict of Interest Code to update the list of designated employees to ensure consistency with the recently updated City Council-approved Personnel Summary.

Recommendation:

c. RESOLUTION DESIGNATING AUTHORIZED AGENTS OF THE CITY OF SIGNAL HILL FOR CALIFORNIA'S OFFICE OF EMERGENCY SERVICES PUBLIC ASSISTANCE GRANTS

Summary:

The City of Signal Hill declared a local emergency in accordance with California Government Code 8630 and the Signal Hill Municipal Code in response to the

COVID-19 pandemic. Staff submitted an application requesting reimbursement for expenses related to the COVID-19 pandemic to the Federal Emergency Management Agency and the California Governor's Office of Emergency Services (Cal OES). Cal OES is requesting the City complete the Request for Public Assistance Application and Cal OES Form 130.

Recommendation:
