Any person wishing to comment shall be allotted three minutes per distinct item. Any meeting may be adjourned to a time and place stated in the order of adjournment.

- a. AUTHORIZATION OF PAYMENT FOR EMERGENCY WATER LEAK REPAIRS AND ACCEPTANCE OF THE COMPLETED EMERGENCY REPAIR WORK

Summary:

On July 20 and July 21, 2023, the City's water system experienced four water leaks that necessitated the coordinated effort of several contractors working on an emergency basis. Staff concluded that the cause of the leaks was an increase in pressure resulting from maintenance work on one of the Cla-Vals (pressure-reducing valves) at Temple Reservoir. In response, the City has taken several proactive measures to prevent similar issues in the future including expediting certain capital project efforts, updating the City's Supervisory Control & Data Acquisition (SCADA) system, implementing new maintenance procedures, and establishing a Mutual Aid Agreement through CalWarn with the City of Long Beach for emergency pipeline repair.

The Signal Hill Municipal Code allows for the temporary suspension of the City's standard procurement process in the event of an emergency. Staff recommends the City Council consider authorizing the City Manager to execute payment for a not-to-exceed amount of \$250,000 for emergency work performed. Funds are available within the Water Department Repair Budget to cover expenses incurred for contractor services used to address the emergency water leaks. Despite efforts by City crews to handle the repairs, the time constraints and extensive work involved in each repair warranted a collaborative effort with three prime contractors: RP Vititow Construction, WA Rasic Construction, and Doty Bros, along with several subcontractors.

Recommendation:

Adopt a resolution, entitled:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SIGNAL HILL, CALIFORNIA, DECLARING THE CITY MANAGER'S AUTHORITY TO EXECUTE PAYMENT FOR EMERGENCY WATER LINE REPAIR WORK CONDUCTED AT MULTIPLE LOCATIONS WITHIN THE CITY ON JULY 20 AND JULY 21, 2023, IN ACCORDANCE WITH THE PROVISIONS OF SIGNAL HILL MUNICIPAL CODE SECTION 3.20.120 AND ACCEPTING COMPLETION OF THE EMERGENCY WORK

- b. AMENDMENT TO THE MAINTENANCE SERVICES AGREEMENT WITH MARIPOSA LANDSCAPES, INC. FOR CITYWIDE LANDSCAPING OF PARKS AND MEDIANS AND RESOLUTION AUTHORIZING BUDGET ADJUSTMENT

Summary:

The City currently contracts with a private contractor, Mariposa Landscapes, Inc. (Mariposa), to maintain its parks. Based on an expressed desire by the City Manager to increase maintenance efforts of the City's parks, medians, and City-owned vacant lots, staff recommends a contract amendment and accompanying budget appropriation to effectuate these goals. The City Council will consider a proposed amendment to the Maintenance Services Agreement with Mariposa for citywide landscape maintenance services. This contract amendment will extend the contract term, increase the contract amount, increase the scope of services to increase cleanup frequency at designated City parks, and provide weed abatement services at vacant City-owned parcels of land.

Recommendations:

1. Authorize the City Manager to execute the First Amendment to Maintenance Services Agreement with Mariposa to provide citywide landscape maintenance services, extending the term by one year through October 1, 2024, increasing the contract amount to a new not-to-exceed amount of \$539,941.13, and increasing the scope of services, in a form approved by the City Attorney.
2. Authorize contingencies of \$50,000 and up to a 180-day term extension pursuant to the City's Purchasing and Contracting Guidelines, to be utilized for as-needed additional services if approved by the Public Works Director.
3. Adopt a resolution, entitled:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SIGNAL HILL, CALIFORNIA, AMENDING THE ADOPTED BUDGET AND AUTHORIZING BUDGET APPROPRIATIONS FOR FISCAL YEAR 2023-2024

c. FIRST AMENDMENT TO THE CITY MANAGER EMPLOYMENT AGREEMENT

Summary:

The City Council conducted its annual review of the City Manager and will consider an amendment to the Employment Agreement.

Recommendation:

Approve the First Amendment to the Employment Agreement for City Manager, in a form approved by the City Attorney.

a. AGREEMENT FOR COST SHARING FOR MONITORING WITHIN THE DOMINGUEZ CHANNEL AND LOS ANGELES AND LONG BEACH HARBORS WATERS TOXIC POLLUTANTS TOTAL MAXIMUM DAILY LOADS

Summary:

The City is required to report on its Total Maximum Daily Load (TMDL) which is the maximum amount of a pollutant that a waterbody can receive and meet water quality standards. Beginning in 2014, the affected cities and agencies worked together with the Los Angeles Gateway Region Integrated Regional Water Management Joint Powers Authority (GWMA) to develop a Memorandum of Understanding (MOU) to share the cost of the implementation plan. The City Council will consider entering into an agreement with GWMA for continued administration and cost sharing of the Harbors Waters Toxic Pollutants TMDL compliance monitoring and reporting plan.

Recommendation:

Authorize the City Manager to enter into an agreement between the City and the GWMA for continued administration and cost sharing for the implementation of the coordinated compliance, monitoring, and reporting plan for the Dominguez Channel and Los Angeles and Long Beach Harbors Waters Toxic Pollutants TMDL.
