- b. AMENDMENT TO THE MAINTENANCE SERVICES AGREEMENT WITH MARIPOSA LANDSCAPES, INC. FOR CITYWIDE LANDSCAPING OF PARKS AND MEDIANS AND RESOLUTION AUTHORIZING BUDGET ADJUSTMENT
