Form of Notice: Notice was published in the Signal Tribune newspaper per Government Code §65091(a)(4) on September 15, 2023; mailed to property owners and residents within a 300' radius of the subject site on September 15, 2023; and posted in accordance with Signal Hill Municipal Code Section 1.08.010 at City Hall, Signal Hill Library, Reservoir Park, and Discovery Well Park on September 15, 2023.

Chis Mata, the authorized agent on behalf of the property owner, Signal Hill Self Storage LP, is requesting an amendment to Conditional Use Permit 00-05 to modify existing and add new conditions of approval for an existing self-storage facility located at 2901 East Pacific Coast Highway within Area 2 of SP-10, Pacific Coast Highway Specific Plan zoning district.

Recommendation:

Adopt a resolution approving the amendment to Conditional Use Permit 00-05 for the existing self-storage facility, entitled:

(13) CITY MANAGER REPORTS**a. ADOPTION OF 2023-2028 SIGNAL HILL STRATEGIC PLAN****Summary:**

The City's Strategic Plan guides the City's vision and goals, serving to accomplish the community's long-term vision, priorities, and objectives, while enabling coordinated efforts among departments. The Strategic Plan also establishes clear benchmarks and performance metrics for accountability that track important milestones and assess the efficacy of programs. The 2023-2028 Strategic Plan, developed with feedback from various community stakeholder groups, establishes the strategic framework that will enable the completion of important objectives. To further focus these efforts, each City Department developed specific workplans that highlight the work each Department and Division will carry out over the next year. Staff will update the Strategic Plan on an annual review cycle to align with the budget adoption process to promote accountability and enable the City Council to reprioritize goals as necessary. Staff recommends adopting the 2023-2028 Strategic Plan substantially in the form presented.

Recommendation:

Adopt the 2023-2028 Signal Hill Strategic Plan substantially in the form presented.

b. PUBLIC WORKS CONTRACT WITH CJ CONCRETE CONSTRUCTION INC. FOR THE FISCAL YEAR 2023-2024 SIDEWALK REPAIR PROJECT (PROJECT NO. 90.24007)**Summary:**

The City Council will consider entering into a Public Works Contract with CJ Concrete Construction Incorporated for the construction of the Sidewalk Repair Project (Project No. 90.24007). This Project is performed annually to improve safe path of travel for pedestrians and is performed in accordance with the City's Sidewalk Inspection Program.

Recommendations:

1. Authorize the City Manager to enter into a Public Works Contract with CJ Concrete Construction Inc. for construction of the Sidewalk Repair Project (Project No. 90.24007), for a term of 30 working days, a not-to-exceed contract amount of \$64,581.00, and in a form approved by the City Attorney.
2. Authorize a project contingency of \$15,419.00 and up to a 30-working day term extension to be utilized by the Public Works Director for additional scope of work to be performed on adjacent streets during construction.
