PUBLIC HEARING TO CONSIDER A REQUEST TO AMEND CONDITION NUMBER THREE OF CONDITIONAL USE PERMIT 09-01 TO ALLOW AN INCREASE TO THE VOLUME OF WASTE PROCESSING AND TRANSFER FOR THE EDCO RECYCLING AND SOLID WASTE TRANSFER FACILITY LOCATED AT 2755 CALIFORNIA AVENUE IN THE GENERAL INDUSTRIAL SPECIFIC PLAN (SP-19) ZONING DISTRICT

Summary:

Form of Notice: The City published the required Notice in the Signal Tribune newspaper per Government Code §65091(a)(4) on May 10, 2024; mailed to property owners within a 300' radius of the subject site on May 10, 2024; and posted in accordance with Signal Hill Municipal Code Section 1.08.010 on or before May 10, 2024.

The applicant, EDCO Transport Services LLC (EDCO), is requesting to modify Condition Number Three of CUP 09-01 for the recycling and solid waste transfer facility (Facility) to allow an increase in the maximum permitted volume of waste that may be processed at the Facility by 1000 tons per day (tpd). This would increase the maximum allowed capacity from the existing weight limit of 1,500 tpd, to 2,500 tpd. No new construction or expansion of the Facility is proposed, all processing will be within the existing footprint of the building.

Summary:

Form of Notice: Notice was published in the Signal Tribune newspaper per Government Code §65091(a)(4) on May 10, 2024; and was posted in accordance with Signal Hill Municipal Code Section 1.08.010 on May 10, 2024.

The City's land use and zoning regulations are contained in Title 20 (Zoning) of the Signal Hill Municipal Code. The Zoning Code carries out the policies of the General Plan by providing standards and guidelines that guide the orderly development of the City. Over time, amendments to the Zoning Code are necessary to clarify existing standards, implement new ones, reflect changes in law, and address evolving land use trends. Action taken by the Planning Commission would not approve any specific development; it would amend sign requirements to be consistent with case law. Amendments to the sign code would be applicable Citywide.
