MINUTES OF A REGULAR MEETING SIGNAL HILL CITY COUNCIL May 27, 2025

A Regular Meeting of the Signal Hill City Council was held in-person in the Council Chamber on May 27, 2025.

There was no public business from the floor.

(5) RECESSED TO CLOSED SESSION AT 6:03 P.M.

It was moved by COUNCIL MEMBER COPELAND and seconded by COUNCIL MEMBER WOODS to recess to Closed Session.

Vice Mayor Hansen arrived at 6:03 p.m.

(6) RECONVENED REGULAR MEETING – 7:01 P.M.

Mayor Jones reconvened the meeting and led the audience in the Pledge of Allegiance.

(7) PLEDGE OF ALLEGIANCE

(8) CLOSED SESSION REPORT

The City Attorney reported on the closed session item; there was no reportable action taken.

(9) PUBLIC BUSINESS FROM THE FLOOR ON ITEMS NOT LISTED ON THE AGENDA

There was no public business from the floor.

(10) PRESENTATIONS

- a. PRESENTATION OF THE NEW SPOTLIGHT ON SMALL BUSINESS VIDEO SERIES FEATURING MIA'S CAFÉ BRUNCH & GRILL.

Mayor Jones presented agenda item 10a.

(11) PUBLIC HEARINGS

- a. PROPOSITION 218 PROTEST HEARING - WATER RATE INCREASES

Mayor Jones introduced this item and asked the City Clerk to explain the requirements of Proposition 218, which governs this Public Hearing and the proposed adoption of the rates and charges. The City Clerk indicated that the Public Hearing was set in compliance with Proposition 218 and that the City mailed a notice of this Public Hearing to any record owner whose property is subject to the imposition of the proposed rates and charges and any tenant who is directly liable for the payment of such rates and charges. The date and time of the hearing was set not less than 45 days after the City mailed the notices.

The City Clerk further explained that the purpose of the Public Hearing is for the City Council to hear all oral testimony and consider all written protests concerning the proposed rate increases. The Public Hearing is also held to determine whether there is a majority protest to the proposed rates and whether to proceed with the adoption of the proposed rates.

Property owners and tenants were not required to provide oral testimony at this hearing, written protests submitted directly to the City Clerk indicating opposition to the proposed rate increases were accepted. In order for a protest to be counted, the protest must be submitted in writing prior to the close of the Public Hearing. The Public Hearing will be closed after the City Council has heard and considered all oral testimony. Further, in order to be counted, the protest must be in writing, state it is in opposition to the rate increase, include the location of the identified parcel (by address or assessor's parcel number), and include the name and signature of the person submitting the written protest. Any protest submitted by email or other electronic means was not accepted as a formal written protest.

The City Clerk further indicated that if written protests to the proposed rate increases are presented by a majority of the owners of the identified parcels upon which the charges are to be imposed or tenants directly liable for the payment of the charges, the City Council may not impose the rate increases. If there is no majority protest, the City Council may impose the rate increases. Pursuant to State law governing Proposition 218, in determining whether a majority protest exists, only one written protest per parcel may be counted.

In addition, any member of the public may submit a written legal objection prior to the close of the public comment portion of tonight's public hearing. In order to be valid, the objection must specify the grounds for alleging the City's noncompliance with Proposition 218, provide the location of the identified parcel (street address or assessor's parcel number), and include the individual's name and signature. Failure to submit a written objection that meets these criteria prior to the close of the public comment portion of the public hearing may prevent bringing a legal challenge in the future.

Mayor Jones indicated that the Public Hearing will be conducted in the following manner: staff will first provide a presentation explaining the proposed rate increases; after the presentation, the City Council will open the Public Hearing for any person wishing to speak on this item; and after all testimony has been heard and all valid legal objections have been submitted, the City Council will close the Public Hearing and have a short recess, if needed, to determine if a majority protest to the proposed rates increases has been received (only those written objections and protests submitted prior to the close of the Public Hearing will be counted). Mayor Jones indicated that, to facilitate the discussion, questions from speakers will be acknowledged after the close of the Public Hearing.

Public Works Director/City Engineer Thomas Bekele provided a presentation on

the Water Master Plan, Water Rate Study Report, and Resolution for consideration of establishing rates for water service fees.

The Public Hearing was opened at 7:26 p.m.

Abraham Chira and Julianne Nachtrab, Signal Hill home owners/tenants, spoke in opposition to the proposed water services fees.

Before closing the Public Hearing, Mayor Jones offered anyone who would like to submit or withdraw a written protest the opportunity to do so. No additional written protests were submitted and no legal objections were received, so additional time was not need to respond.

The public hearing was closed at 7:33 p.m.

The City Clerk reported that, prior to the close of the Public Hearing, five written protests were received. The City Clerk further reported that a majority protest does not exist to the proposed rates for the water service charges.

The City Council proceeded to discuss the proposed rates for the water services charges and clarified that the rates are not cumulative. The City Council also responded to questions surrounding water conservation and the associated rates. Council Member Honeycutt acknowledged Mr. Chira for his involvement in this process. In response to a question from Council Member Copeland, staff provided brief information about the program for economic assistance for lower income residents. Vice Mayor Hansen reiterated the process for the consideration of revising water service fees, which began many months ago. Mayor Jones indicated that careful consideration has been given to these fees to determine the best path forward. The City Council indicated that all options were weighed and that this decision is not taken lightly; all Council Members pay the same fees as residents.

It was moved by COUNCIL MEMBER WOODS and seconded by COUNCIL MEMBER COPELAND to receive, file, and adopt the Water Master Plan; receive and file the Water Rate Study Report; and adopt Resolution No. 2025-05-6875, entitled:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SIGNAL HILL, CALIFORNIA, ESTABLISHING RATES FOR WATER SERVICE FEES AND TAKING OTHER ACTIONS RELATED THERETO.

Director of Public Works/City Engineer Bekele and Contracts Manager Margarita Beltran provided a presentation on this item and responded to questions from the City Council. 
(14) COUNCIL AGENDA--NEW BUSINESS
