An Adjourned Regular Meeting of the Signal Hill City Council was called to order in the Council Chamber of City Hall on August 28, 2012.

REPRESENTATIVES FROM SIGNAL HILL PETROLEUM CONDUCTED A TOUR OF THE SEVEN SIGNAL HILL PETROLEUM DRILL SITE FACILITIES

Representatives from Signal Hill Petroleum conducted a mobile and walking tour of their seven drill sites in the City. In addition to members of the city council and city staff, members of the public included Bob Mendoza, Gloria Nava, and Maria Harris. Employees of Signal Hill Petroleum included John Perry, Robert Stewart, Sean McDaniel, Brady Barto, Kevin Laney and Amanda Kilpatrick. The tour began at 4:15 p.m. and ended at 5:45 p.m. The information and questions from the public and council members covered descriptions and visual inspection of all facilities at each of the seven drill sites, an explanation of the computerized oversight reporting system to AQMD and other agencies, drilling and production activities, electric power generation and use, water treatment and re-use, product transport, and water injection details.

The locations of the drill site that were visited are as follows:

- #1 - 3303 California Avenue (North of Spring St. between California and Atlantic Aves.).
- #2 –1215 E. 29th Street (South of Spring St. between Orange and Gundry Aves.)
- #3 – 1755 Willow Street Avenue (North of Willow between Walnut and Cherry Aves.).
- #4 – 2398 Combellack Drive (South of Junipero Ave. and Combellack Dr.).

#5 - 2698 Combellack Drive (South of Combellack Dr. and west of Temple Ave.)

#6 – 3365 Grant Street (North of Grant St. between Obispo and Redondo Aves.).

#7 – 3300 Grant Street (South of Grant St. between Obispo and Redondo Ave.)
