REORGANIZATION

PUBLIC HEARING

1. Conditional Use Permit for a Rooftop Wireless Telecommunication Facility located at 3275 Grant Street

Summary: The applicant, Clearwire, is requesting approval to construct and operate a wireless telecommunications facility on the rooftop of an industrial office building at 3275 Grant Street in the LI, Light Industrial, zoning district. The applicant will share the rooftop with an existing wireless telecommunications facility operated by T-Mobile that is camouflaged by a screen wall.

Recommendations: 1) Waive further reading and adopt a resolution recommending City Council approval of Negative Declaration 05/28/10(1); and 2) Waive further reading and adopt a resolution recommending City Council approval of Conditional Use Permit 10-04.
