PUBLIC HEARING

1. Long Beach Islamic Center

Summary: In 2007 the City approved a Site Plan and Design Review (SPDR) and a Conditional Use Permit (CUP) requested by the Long Beach Islamic Center for construction of a religious facility at 995 27th Street in the CG, Commercial General, zoning district. The SPDR approval expired in 2009 prior to commencement of construction. In 2009, the applicant submitted a new application and a second approval was granted. Construction began, but stalled with the building partially completed. The building permits, SPDR and CUP approvals all expired in May 2013.

The applicant is once again requesting approval of the SPDR and CUP for the same project that was approved in 2007 and in 2009. They have reported that recent fundraising efforts have allowed them to hire a professional project manager and fundraising event coordinator. They have submitted a letter acknowledging the requirements of the new Construction Time Limits Ordinance and state that they are capable of completing the project within the provisions of the ordinance.

Recommendations: 1) waive further reading and adopt a resolution recommending City Council approval of Conditional Use Permit 13-02; and 2) waive further reading and adopt a resolution approving Site Plan and Design Review 13-04.
