CALL TO ORDER

Chair Wilson called the meeting to order at 7:00 p.m.

PUBLIC HEARING

a. **PUBLIC HEARING FOR REVISIONS TO SITE ACCESS FOR AN ADULT DAY CARE FACILITY WITH A CONDITIONAL USE PERMIT AT 695 E. 27TH STREET**

Community Development Director Charney read the form of notice and Assistant Planner Agbayani gave the staff report.

Commissioner Bell asked if the shared driveway and drive aisle would serve emergency vehicles for both properties. Staff confirmed that emergency access for both properties will be from the shared driveway and drive aisle.

The State Director for Dungarvin, Julia Lowe, introduced herself and yielded her time to answer any questions.

Commissioner Parker asked the applicant if they had any safety concerns with the removal of the fence. Ms. Lowe noted that client safety is always a priority, and outlined some of the company's safety monitoring practices.
