CALL TO ORDER

PUBLIC WORKSHOP

- a. Preliminary Review of A Target Retail Center and New Self-Storage Facility

Community Development Director Doan gave the form of notice, and Economic Development Manager McCaleb gave the staff report.

Vice Chair Bell asked for clarification regarding the proposed Conditional Use Permit (CUP) for alcohol sales.

Staff clarified that Target does not currently sell alcohol at this location and that the CUP would allow for alcohol sales for off-site consumption only.

Commissioner Lopez commented that the proposed drive-up pick-up stalls take up a significant portion of the available parking. He also expressed concerns related to traffic impacts to the surrounding areas.

Community Development Director Doan, intervened in the discussion. She and Assistant City Attorney Nguyen noted that they had just then deduced that the Zoom meeting ID and passcode that were published on the agenda were incorrect; therefore, the public workshop would have to be ended, rescheduled and re-noticed, in conformance with the Brown Act.

Under counsel of Assistant City Attorney Nguyen, Chair Richárd ended the workshop without opening the public comment period.
