**CALL TO ORDER**

Chair Richárd called the meeting to order at 7:02 p.m.

**PLEDGE OF ALLEGIANCE**

Chair Richárd led the audience in reciting the Pledge of Allegiance.

**PUBLIC BUSINESS FROM THE FLOOR**

There was no public business from the floor.

**PUBLIC WORKSHOP**

- a.     Preliminary Review of A Target Retail Center and New Self-Storage Facility

Community Development Director Doan gave the form of notice, and Economic Development Manager McCaleb gave the staff report.

Commissioner Wilson asked if Caltrans was aware of the project, given its close proximity to the I-405 freeway, and also commented on the existing homeless encampments nearby.

Vice Chair Bell asked if there is any City benefit associated with the development of the site.

Economic Development Manager responded that the Planning Commission will see the details of the Development Agreement once it becomes finalized.

Chair Richárd opened the public workshop.

John Clement with Venture Point Inc., introduced himself as one of the applicants and thanked staff for preparing the report.

Commissioner Wilson commended the applicant for incorporating "Signal Hill" onto the freeway-oriented monument sign.

Debra Layton with Signal Hill Petroleum introduced herself and expressed her team's excitement in developing the site.

Nick Pugh, property owner of 3310 Lime Ave, stated that he liked the overall design of the Target renovation and self-storage facility; however, he was opposed to the proposed drive-thru restaurant adjacent to the existing Chick-Fil-A. He expressed concern related to traffic impacts. He suggested construction of an open space area for public gathering with minimal retail (similar to the existing SteelCraft development in Long Beach). He emphasized deviating from a car-centric drive-thru establishment and instead constructing a pedestrian-friendly space, which may help to alleviate potential traffic impacts.

Chair Richárd then closed the public workshop.

Commissioner Lopez commented that he likes Mr. Pugh's suggestion of a park-like design in place of the drive-thru restaurant.

Commissioner Parker asked if traffic impacts for the proposed drive-thru was considered in the traffic analysis.

Staff confirmed that it was included in the report. Additionally, the applicant is required to re-visit traffic impacts when the drive-thru restaurant undergoes the Site Plan and Design Review process.

Chair Richárd asked if there was a timeframe for circulation of the CEQA document.

Staff replied that the target circulation date of the CEQA document is March 26, 2021.

Chair Richárd made a motion and called for a roll call vote to bring the project forward to a future public hearing.
