1. CONTINUATION OF WORKSHOP — ANIMAL BOARDING (KENNEL)

Summary: The Planning Commission will continue discussion on a zoning ordinance amendment related to animal boarding (kennel). Animal boarding is currently permitted as a conditional use in the GI, General Industrial, zoning district and as an accessory use in the SP-6, Commercial Corridor Specific Plan, zoning district. The Commission will hear public testimony and consider an amendment to the zoning ordinance to expand such use to other commercial and industrial zoning districts.

Recommendation: Receive public comment and provide direction as deemed appropriate to initiate a zoning ordinance amendment.

2. WORKSHOP – OPEN MEETING LAW

Summary: on December 6, 2011, the City Council conducted a workshop on the Ralph M. Brown Act or California's Open Meeting Law (Attachment A). The workshop was an opportunity for the Council to review current public meeting practices and discuss whether current practices should be modified. It also an occasion to educate the public on the law and City practices. The City Attorney will brief the Planning Commission on the items covered and outline the main features of a draft procedural manual intended to be used by the Council and Commissions to ensure that meetings are conducted in a standardized manner (Attachment B).

Recommendation: After receiving public testimony, direct staff to advise the Council of any input prior to its consideration of a resolution implementing the various provisions of the Brown Act.
