The Commission will render its judgment as soon after the conclusion of the hearing as possible and in no event later than ten working days after conducting the hearing and shall direct staff or the Commission's Counsel to prepare written findings in accordance with its judgment. Action of the Commission will not be final until the document setting forth the Commission's findings is signed by the Commission.

If the proceedings are not completed by 10:00 p.m. on Monday, November 26, 2012 then the Commission will adjourn the hearing to Wednesday, November 28, 2012 at 6:00 p.m. in the Council Chambers to continue the appeal hearing of Reina Schaeztl.
