## **PRESENTATIONS AND AWARDS**

This Quarter's recipient of the Planning Commission's Beautification Award is the new Signal Hill police facility located at 2745 Walnut Avenue. The facility is seeking LEED certification for its green building design; however, the beauty of the architecture and landscaping are the focus of the award. The entry area features tall ceilings and ceiling high windows. The use of natural light is maximized throughout and the exterior has native and drought tolerant plants and sky blue roofing. The site has beautiful views from the inside and out.

## **WORKSHOPS**

### **1. Revised Architectural Treatment for Medical Office Building at 845 Willow Street**

**Summary:** The applicant, Ware Malcomb for 2H Construction, is requesting review of plans for a two-story, 18,994 square foot medical office building on a 1.32 acre site at 845 Willow Street in the CG, Commercial General, zoning district. Plans for the project were approved in 2009 but the Site Plan and Design Review approval has since expired. The site plan has been modified to shift the building from its previous location in the rear portion of the property to a more prominent location along Willow Street. This modification was made in response to the City's interim urgency ordinance regarding development on properties with previously abandoned oil wells.

The Planning Commission reviewed the initial concept for the revised plans at a workshop in March. At that time, the Commission requested changes to the architectural treatment of the elevation facing Willow Street. The applicant is currently preparing alternatives in response to Commission direction and will present them to the Commission at the workshop.

**Recommendation:** Receive public comment and provide direction as deemed appropriate.

## 2. Trucking Yard Draft Compliance Plans and Use Reclassifications

**Summary:** In 2006, due to nuisance concerns related to trucking yards, the City Council adopted a trucking yard Ordinance and concurrently established a list of twelve existing trucking yard properties. Performance standards were adopted for *new* trucking yards, but none were established for existing trucking yards. In 2012, due to complaints about operations, the City Council directed the Planning Commission to develop performance standards for existing trucking yards. Since that time, staff has conducted two workshops, completed extensive research and outreach to property and business owners, and prepared draft compliance plans. The property research indicates that only a few of the businesses on the existing trucking yard list actually fit the City's definition of a trucking yard. In preparation for the third workshop, staff has met with or spoken to nearly all the property owners and tenants in an effort to better understand their business operations. Staff will review these details for each property as well as the City's definitions for trucking yards, storage yards and other types of yards. The workshop format is used to encourage public participation, clarification and discussion on the topic.

**Recommendation:** Receive public comment and provide direction as deemed appropriate.

## 3. Construction Time Limits

**Summary:** The Planning Commission will revisit construction time limits, including possible performance standards, extensions, fees and penalties.

**Recommendation:** Open the workshop; receive testimony and direct staff to proceed in drafting a regulatory response based on the recommendations of the Commission.

**Summary:** Government Code Section 65400 mandates that all cities submit to their legislative bodies an annual report on the status of the General Plan and progress in its implementation.
