### Low Income Preferential Parking Fee Waiver

Do you qualify for the City of Signal Hill's Parking Permit Fee Waiver? The City of Signal Hill offers a low income fee waiver for preferential parking permits (excluding guest permits). The chart below shows the maximum income allowed for each qualified household.

3	\$49,720
4	\$60,000
5	\$70,280

7	\$90,840
8	\$101,120
Each Additional Person	\$10,280

\* Gross income means all income of all persons who live in the home both taxable and nontaxable. Households with more than 8, please contact the City of Signal Hill, for the income calculation.

If your household size and income does not exceed the guidelines in the above chart, and you think you may qualify, please complete a customer application for Preferential Parking Fee Waiver on the following page. Please provide proof of income by attaching a copy of your 2022 form 1040, form 1040EZ, form 540, form SSA-1099, or a Verification of Benefits form.

Once the completed application is reviewed and approved, the Finance Department will notify you of your fee waiver status. Return all the required documents to the City of Signal Hill, 2175 Cherry Avenue, Signal Hill CA 90755.

## Low Income Preferential Parking Fee Waiver Application

- Employment, child support, alimony, interest, dividends, business or rental income and support from family and friends.
- Social Security, Veteran, Disability, Unemployment and Retirement benefits.
- AFDC, SSI, cash, public assistance and Food Stamps.
- School grants, loans or other aid.
  
- I will notify the City of Signal Hill if I move or exceed the income limits.
- I am not claimed on another person's income tax return.
- **I understand that the City of Signal Hill reserves the right to verify my household's income. Please provide proof of income by attaching your 2022 form 1040, form 1040EZ, form 540, form SSA-1099, or Verification of Benefits form.**
- If the City of Signal Hill finds that I received a fee waiver when I was not eligible, the city may back bill for the applicable fees.
