**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SIGNAL HILL, CALIFORNIA, APPROVING AND ADOPTING A SIDE LETTER OF AGREEMENT BETWEEN THE CITY OF SIGNAL HILL AND THE SIGNAL HILL EMPLOYEES' ASSOCIATION**

**WHEREAS**, on June 11, 2024, the City Council of the City of Signal Hill adopted Resolution No. 2024-06-6815 for the purpose of adopting the Memorandum of Understanding (MOU) between the City and the Signal Hill Employees' Association (SHEA); and

**WHEREAS**, SHPOA representatives and City representatives mutually agreed to amend the adopted July 1, 2024-June 30, 2027 MOU and incorporate the classification plan amendments; and

**WHEREAS**, a Side Letter of Agreement between the City and SHEA (Side Letter Agreement) subject to Council approval, is attached hereto as Exhibit A and incorporated herein by this reference.

**NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF SIGNAL HILL, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:**

1. The Side Letter Agreement attached hereto as Exhibit A is approved and adopted.
2. The Side Letter Agreement amends the MOU between the City and SHEA.



**CLASSIFICATION PLAN AMENDMENTS**

On June 11, 2024, the City of Signal Hill ("City") and the Signal Hill Employees' Association ("SHEA") entered into a Memorandum of Understanding ("MOU") for the period of July 1, 2024 through June 30, 2027. In March 2025, the City assessed the classification plan as it pertains to recruitment and retention efforts and succession planning.

The parties have met and conferred in good faith and reached this Side Letter Agreement (the "Agreement") to implement the classification plan changes listed below; and incorporate these classification plan amendments into the SHEA MOU:

The City and the SHEA enter into this Side Letter of Agreement and hereby agree to the following:

**D. Senior Public Works Inspector – Job Specification Revision (attached).**




