The City of Signal Hill's Privacy Policy is available at www.cityofsignalhill.org.

The City of Signal Hill takes your privacy seriously. Our privacy policy is clear: We will collect **no** personally identifiable information about you when you visit our web site or use our services unless you choose to provide that information to us.

What this Privacy Policy Covers

This Privacy Policy covers this website's treatment of personally identifiable information that the City of Signal Hill collects when you are on this website and when you use this website's services. This policy does not describe information collection policies on other sites, including those linked to or from this site.

Children's Issues

No application on the City of Signal Hill's web site specifically solicits information from minors or seeks to determine whether the visitor is a minor. Consequently, visitors should be aware that the collection of personal information requested from or volunteered by children online or by e-mail will be treated in the same manner as information given by an adult. This information may become a public record, and as such may be subject to public access. We ask that parents guide their children when children are asked to provide personal information online.

This site is not directed to children under 13 years of age, and children under 13 years of age shall not use the web site or services offered by this site to submit any individually identifiable information about themselves.

What Type of Information We Collect

The City of Signal Hill does not collect any personally identifiable information about you through this website other than information that you affirmatively choose to submit to us. The City of Signal Hill may automatically collect aggregate information about the use of its site, including which pages are most frequently visited, how many visitors we receive daily, and how long visitors stay on each page.

How We Use the Information We Collect

If you send us an e-mail message with a question or comment that contains personally identifiable information, or fill out a form that transmits this information, we will only use the personally identifiable information to respond to your request. We may redirect your message to another government agency or person in a better position to answer your question.

In order to provide you with the e-mail-based newsletters and other information in which you have expressed an interest, it is necessary for the City of Signal Hill to collect your e-mail address. This information is used only for distribution of newsletters of other information which you have requested or for which you have registered, and to notify you from time to time about services offered by the City of Signal Hill or other entities associated with the City of Signal Hill. By agreeing to use this service, you are granting us permission to send you periodic e-mails only about topics for which you registered. The City of Signal Hill will use your e-mail address only for this permission-based e-mail service, and otherwise does not share personally identifiable information with any third party without your permission.

With Whom We Share Information

We may disclose information about you if we have a good-faith belief that we are required to do so by law or legal process, to respond to claims, or to protect the rights, property or safety of the City of Signal Hill or others.

The City of Signal Hill does not collect data for commercial purposes, and does not sell, exchange or otherwise distribute the data collected by its website or online services for commercial purposes. This information is not reported or used in any manner that would reveal personally identifiable information, and will not be released to any outside parties unless required to do so under applicable law or in the circumstances described in this section.
